PULPIT SUPPLY LIST - June 2025

The Pulpit Supply List is published by Eastern Oklahoma Presbytery's Committee on Ministry to aid churches as they search for **occasional** preachers to fill the pulpit when their pastor is absent. Individuals included on this list have indicated their willingness and availability to preach and officiate communion (where permitted). They are persons in good standing, have been approved by COM, have passed a background check, and have completed the Presbytery's Sexual Misconduct Training. (See the Eastern Oklahoma Presbytery's Sexual Misconduct Policy for more details about requirements.)

The recommended minimum honorarium for pulpit supply is \$150, plus appropriate mileage (the 2025 IRS standard mileage rate is **70 cents/mile**.) If honorarium is less than the recommended amount, please discuss with pulpit supply pastor before they preach. Grants for 1/3 of the recommended minimum honorarium are available through the Small Church Ministry Grant Application. Sessions are encouraged, as far as possible, to consider diversity of gender and ethnicity when selecting leaders for congregational worship.

Authorizations: PCUSA ministers may preach, officiate Communion or Baptism. Commissioned Pastors may only preach and officiate communion outside of their commission. Certified Ruling Elders approved by presbytery (formerly Lay Preachers) may preach and, if requested by Session, officiate Communion. All other categories of persons may only preach.
